### NOTE FROM THE CHAIRMAN LARKIN MOYER



The Piedmont Soil and Water Conservation District (SWCD) is one of 47 SWCDs in Virginia. Most counties in Virginia are supported by a District, and there are 3,000 conservation districts nationwide. Districts are governmental entities that work on the local level to improve soil and water quality through voluntary conservation measures. Districts also provide natural resource education to students and adults. Programs are initiated by an elected Board of Directors and are carried out by staff members. Board members volunteer their time and are not paid officials. They are committed to protecting the health of our natural resources and

representing the conservation concerns of the local citizens. We look forward to continuing our work conserving the natural resources of Amelia, Nottoway, and Prince Edward Counties and protecting our local waters flowing to the Chesapeake Bay and Albemarle Sound.

### **Piedmont SWCD Honors Reuben Blanton**

At the February 2019 meeting of the Amelia County Board of Supervisors, PSWCD Chairman Larkin Moyer presented a resolution honoring late farmer Reuben Blanton. Mr. Blanton was a long-time supporter of natural resources conservation and went above and beyond in his efforts to be a good steward of the land. He implemented Best Management Practices (BMPs) on his farm, including stream exclusion, riparian buffer plantings, cover crops, and nutrient management plans. Additionally, he supported conservation education by hosting tours on his farm for local students, farmers, and government officials. The Piedmont SWCD is grateful for Mr. Blanton's contribution to conservation and to the local farming community.





### FINANCIAL OVERVIEW

The Piedmont Soil and Water Conservation District serves Amelia, Nottoway, and Prince Edward Counties. We operate primarily on a grant basis with funds from state and local governments. Some programs we administer are based on watershed location (such as grants only available for Chesapeake Bay residents), while other programs are available to residents in all three counties that we serve. Every two years, an independent audit is performed, and the District received successful audit results this


### AGRICULTURAL CONSERVATION

Piedmont SWCD administers a state grant-funded cost-share program to agricultural producers who install and implement best management practices (BMPs) to improve soil and water quality. Certified, trained staff provide technical assistance to producers by identifying natural resource concerns, providing conservation planning, and ensuring practices are installed and functioning correctly. Technical assistance is always free of charge, and participation in the programs is voluntary.



In partnership with the Virginia Association of SWCD's Legislative Committee, the Piedmont SWCD hosted a successful tour for the Secretary and Deputies of Natural Resources, Director of Department of Conservation and Recreation, Deputy Secretary of Forestry, and Director of Virginia Department of Agriculture and Consumer Services. The event consisted of a presentation about the many roles carried out by Virginia SWCDs as well as their funding needs. To show the attendees a realworld example of the partnership between SWCDs and the agricultural community, Piedmont SWCD organized a tour of Mountain View Farm, operated

by Don and Janet Benson of Amelia. The Bensons are past recipients of the Piedmont SWCD Conservation Farmer Award for their ongoing effort to conserve the natural resources on their farm.

### **RESIDENTIAL CONSERVATION**

Piedmont SWCD administers two grants from the Department of Environmental Quality to provide financial assistance to homeowners for a percentage of the costs of septic system pump outs, repairs, and replacements. The program also educates residents about proper septic system care and about the environmental and health impacts of failing septic systems. Applicants must live in the Flat, Nibbs, Deep, or West Creek watersheds in Nottoway and Amelia Counties, or the Spring Creek, Briery Creek, Sandy River, Bush River, or Saylers Creek watersheds in Prince Edward County. Contact the District to find out what watershed you live in.

The photo to the right shows a septic tank pump-out in progress. The Virginia Department of Health recommends pumping your septic tank every 5-7 years to properly maintain it. Not performing routine maintenance can cause a buildup of solids, which could clog the drainfield lines, resulting in a costly system replacement.



### **Controlling Erosion and Stormwater Runoff**

Piedmont SWCD staff gave a presentation at the May 2019 Lunch and Learn event hosted by Prince Edward County Virginia Cooperative Extension and the Heart of Virginia Master Gardeners. The purpose of the Lunch and Learn program is to educate the public about various natural resource and gardening subjects. The presentation by Piedmont SWCD focused on common erosion and stormwater problems in residential settings and the steps homeowners can take to solve them. The primary topic was an overview of Best Management Practices (BMPs), which are implemented to address natural resource concerns. BMPs that can remedy erosion and stormwater runoff include conservation landscaping, rain gardens,



and rainwater harvesting. Attendees also learned about the benefits of choosing plants that are native to the Piedmont region of Virginia. Native shrubs and grasses protect against erosion and stormwater runoff as they have deeper root systems than lawn grass. The deep roots act as an anchor to hold soil in place and also function as a sponge to absorb excess runoff. The District informed the group about the Virginia Conservation Assistance Program (VCAP), which is a cost-share program that incentivizes homeowners and businesses to install stormwater BMPs. In support of VCAP this year, District staff made ten site visits to assist landowners with erosion and stormwater issues.

### **EDUCATION & OUTREACH**


Education for youth and adults is a key initiative for Piedmont SWCD. Youth education includes classroom programs, Envirothon program, camps, poster contest, interactive displays, and scholarships to continue higher education. Adult education consists of exhibits at public events, newspaper and radio releases, social media outreach, and workshops.

During Ag Awareness Days, students crawled through a soil tunnel, which displays soil layers and components. They learned about the role of soil and its importance in providing the resources we use daily.

The District participated in Ag Awareness Days, which educate local third graders about natural resources. The Piedmont SWCD partnered with USDA Natural Resources Conservation Service (Derek Hancock) to teach students about the layers of the soil, as shown in the middle photo above.

## WATERSHED DAMS

Piedmont SWCD is responsible for maintaining and meeting the safety regulations of 14 flood control dams in Prince Edward County. These dams are designed for watershed protection and flood prevention. All dams have an approved Emergency Action Plan that is utilized during significant storm events.

Tropical Storm Michael impacted Prince Edward County on October 11, 2018, dropping over 5-10 inches of rain in less than 5 hours and causing widespread wind damage. Out of the 14 flood control dams the District is responsible for, five auxiliary spillways activated and suffered damages, several culverts at access roads were damaged, and numerous tree debris washed onto risers and dams. Repair work is currently underway.
