### **Grazing Plan Assistance**

Receive assistance with the design of a prescribed grazing plan for better forage utilization and healthier pastures. Free of charge.

#### **Conservation Planning Assistance**

Receive assistance with farm-wide conservation planning. Free of charge.

### Resource Management Planning Program

A certification that helps producers meet future state standards associated with nutrient, sediment, and water quality. Certification is valid for 9 years provided the producer continues to implement the plan. Participation is voluntary.

# Most Popular Practices Cover Crops

- Best Management Practices designed to reduce soil erosion and capture excess nutrients on cropland
- Incentive payments based on acres enrolled in practice
- Kill, harvestable & legume options
- May receive tax credit in lieu of payment



### **Riparian Forest Buffer**

Incentive payment based on acres planted and practice lifespan

- Hardwood or conifer options
- 95% cost share on eligible establishment costs



### **Conversion of Cropland to Grass**

- Incentive payment based on acres planted and practice lifespan
- 75% cost share on eligible establishment costs

# <u>Livestock Stream Exclusion</u> <u>Many new options!</u>

- Cost share rates (up to 100%) based on buffer width and practice lifespan
- Rental payment on wide buffers
- Options for water source
- New grazing management practices



### **Continuing Conservation Initiative**

Incentive payments to maintain voluntarily installed conservation practices or out of lifespan cost share practices

- Forest or herbaceous buffers
- Stream exclusion fence
- Stream exclusion fence and associated water system
- Waste Structures

### **Animal Waste Practices**

### **New Options Include**

- Feeding Pad
- Manure Storage
- Manure Injection
- Confined Feeding Operation
- Winter Feeding Facility
- Loafing Lot Management-(Non-Dairy)



# **Nutrient Management**

Protect water quality while maximizing production and reducing nutrient runoff.

### **Nutrient Management Plan Writing**

- Plans written or revised by Virginia certified private planner
- Incentive payments based on acres enrolled and manure source

### **Nutrient Management on Cropland**

- Precision Nitrogen and Phosphorous Options
- 75% cost share on application charge, maximum of \$8/acre
